Dryvit Systems Canada, hereafter referred to as "DRYVIT", warrants that Dryvit Textured Acrylic Finishes and Dryvit Primer used in TAFS Option 1, or the TAFS, basecoat and reinforcing mesh used in TAFS Option 2, (hereinafter collectively the "TAFS Products", manufactured by Dryvit, when applied in accordance with the Dryvit's written specifications and application instructions, will not delaminate for a period of Ten (10) years from the date of application. This warranty does not cover failures or defects which are due to the failure on any building component, materials not manufactured or sold by Dryvit. This warranty does not cover failures or defects resulting from improper installation of the TAFS Products or workmanship, improper storage, abuse, vandalism, damage from accidental causes or negligence by any person, thermal movement, structural movement, structural failure, acts of God, engineering or design deficiencies, or defective or insufficient caulking.

IN NO EVENT SHALL DRYVIT BE LIABLE FOR AND EXPRESSLY DISCLAIMS ANY LIABILITY FOR ANY OTHER DAMAGE TO THE BUILDING ITSELF, ITS CONTENTS OR FOR ANY OTHER CONSEQUENTIAL OR INCIDENTAL DAMAGE, WHETHER IN CONTRACT OR IN TORT, INCLUDING NEGLIGENCE. THIS WARRANTY IS GIVEN IN LIEU OF ANY AND ALL OTHER WARRANTIES WRITTEN OR ORAL, EXPRESS OR IMPLIED. THE REMEDY SET FORTH HEREIN IS THE SOLE AND EXCLUSIVE REMEDY FOR ANY AND ALL CLAIMS ARISING UNDER OR IN CONNECTION WITH OR IN ANY WAY RELATING TO THE DRYVIT MATERIALS SUPPLIED AND INSTALLED ON THIS PROJECT. NO REPRESENTATIVE HAS THE AUTHORITY TO VARY OR ALTER THESE TERMS.

The sole responsibility and liability of Dryvit under this warranty shall be to repair or replace the Dryvit TAFS Products described herein shown to be defective during the warranty period. Any claim under this warranty must be made prior to the expiration of the warranty period. This warranty is for material only; the contractor warrants his workmanship separately.

The remedies provided in this warranty shall be exclusive and no person is authorized to make any other warranty, express or implied, on behalf of Dryvit. THIS WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. IN NO EVENT SHALL DRYVIT BE LIABLE FOR ANY INCIDENTAL, SPECIAL, OR CONSEQUENTIAL DAMAGES RESULTING FROM THE USE, INSTALLATION, PERFORMANCE OR FAILURE OF THE PRODUCT. This warranty shall be interpreted under the laws of the Province of Ontario.

Dryvit shall not have any obligations under this warranty unless the owner notifies Dryvit Systems Canada: Stouffville, Ontario; L4A 8C1; Attn: Warranty Services; in writing, within thirty (30) days of discovery of alleged defects. Dryvit shall be allowed a reasonable period of time, authorization to remove samples, and to perform any testing Dryvit deems necessary to investigate and determine the cause of the defect. The Owner shall provide and cause any temporary repairs to be accomplished in a timely manner to prevent further damage to the structure or contents of the building until the cause of the defect is determined and permanent repair recommendations may be made.

Dryvit shall not have any obligations hereunder unless the system shall have been maintained by the owner with reasonable care.
